

Reciprocal IEEPA Tariff Fact Sheet

Minimum base tariff – 10% for all countries not listed below.

- Effective for all goods **entered after midnight 5 April**, in addition to any regular duty and tariffs in place.
- USMCA originating and compliant goods are exempt from the reciprocal tariff.
- Goods currently subject to Sec. 232 are exempt.
- Sectoral goods – automobiles, lumber, copper, pharmaceuticals and semiconductors, energy and critical minerals are exempt.
- Goods under 50USC 1702(b) – such as informational and artworks are exempt.
- Non-USMCA goods from Canada and Mexico subject to previously imposed 25% IEEPA tariff.
- The 10% rates of duty and the other reciprocal rates shall only apply to the non-U.S. content of an article, provided at least 20 percent of the value of the subject articles is U.S.-originating.

Country specific reciprocal tariff levels:

- Effective for all goods **entered after midnight 9 April**.
- 5 April base rate increases to below listed rates, in addition to any regular duty and tariffs in place.
 - For example, China will stack existing 301, IEEPA and reciprocal for a 79% rate.
- Goods loaded onto a vessel at the port of loading and in transit on the final mode of transit before 12:01 a.m. eastern daylight time on April 9, 2025, are exempt.
